1. Prospective purchasers will be offered to view the selected specified residential property, or comparable residential property if it is not reasonably practicable for the selected specified residential property to be viewed by the prospective purchasers, before entering into the preliminary agreement for sale and purchase.

準買家在簽署買賣合約前，將獲安排參觀所揀選的指明住宅物業。如開放所揀選的指明住宅物業供準買家參觀並非合理地切實可行，則準買家在簽署臨時買賣合約前，將獲安排參觀與所揀選的指明住宅物業相若的住宅物業。

2. Only individual(s) of at least 18 years old or limited company(ies) incorporated in Hong Kong or non-Hong Kong company(ies) registered under Part 16 of the Companies Ordinance (At least one director of such limited company or non-Hong Kong company shall be natural person) shall be eligible to submit tenders.

3. The Vendor does not bind itself to accept the highest or the best or any tender and has the absolute discretion in relation to the acceptance of a tender. The Vendor has the absolute right to withdraw from the sale of any specified residential property at any time before the acceptance of any offer. The Vendor has the absolute right to change the tender closing date and/or time of the tender from time to time by amending the Sales Arrangements.

Although a specified residential property may be available for tender on a Date of the Sale, it may become unavailable during that Date of the Sale or after the close of tender on that Date of the Sale because the Vendor may have accepted a tender of that specified residential property submitted in a previous tender exercise on a previous Date of the Sale (which is open for the Vendor to accept

within 5 working days after the close of that previous tender exercise). Please also note that the register of transactions of the Development may not be updated immediately after the Vendor accepts a tender.
